## CONFEDERATION OF ENGLISH FISHERS Fly Fishing Event; Safety & Risk Assessment Statement.

It is the duty of the Federations to familiarise its members, officials and participating anglers with the principles of safety and risk assessment. All members, officials and participating anglers should make themselves aware of the risks they face in the surroundings they find themselves and carry out their own risk assessment which generally amounts to common sense and take appropriate action to ensure their own safety and that of others. However, **it is a requirement of partaking in the Fly Fishing event indicated below** that all anglers read, understand and accept this Fly Fishing Event; Safety & Risk Assessment Statement.

### General Risks Associated With Angling

<b><u>Paths</u></b>	Only use obvious paths along the bank, and to and from a jetty or platform.
<b><u>Banks</u></b>	Beware of undercuts in banks especially near deep water.
<b><u>Wading</u></b>	Take particular care when wading in deep or fast water and on rocky bottoms. <b>It is recommended that you use a wading staff and wading belt at all times.</b>
<b><u>Power lines</u></b>	Beware of fishing under power lines and remember electricity can arc over considerable distances. You are ideally earthed in water to conduct electricity. Remember that graphite is an excellent conductor of electricity.
<b><u>Lightning</u></b>	Again you are ideally earthed when in water and, if using a graphite rod, you have a good lightning conductor. If you are on a boat you and your rod may well be the highest point around and a prime target for a strike.
<b><u>Casting</u></b>	Always show consideration to others users or a riverbank by avoiding contacting anyone with you back-cast. If you are on a boat take extra care if you have other occupants, as you can easily contact them whilst casting. <b>It is recommended protective glasses are worn when fishing to protect your eyes from hooks etc.</b>
<b><u>Hooks / Flies</u></b>	Hooks by their design are sharp and easily penetrate the skin. Their use brings them into contact with germs etc. that can be injurious to health. Caution should be used when handling hook, tying on or removing hooks. Rusty hooks should be avoided at all times.
<b><u>Weighted Flies</u></b>	Weighted flies cause unpredictable movement of the cast when casting. Extreme caution should be exercised when casting weighted flies to ensure they do not come into contact with you, fellow anglers or the public.
<b><u>Trees</u></b>	Fishing under trees can be unsafe in windy conditions. Beware of falling branches.
<b><u>Animals</u></b>	Do note that Bulls can be troublesome! As can Cows with Calves. Approach the river with caution.
<b><u>Weils Disease, sewage effluent</u></b>	This is transmitted in rat's urine. Never put wet lines in your mouth or any other items of tackle that has been in the water. Wear waterproof plasters on any cuts or abrasions. There may also be a risk in some waters from treated sewage effluent
<b><u>Fishing Platforms</u></b>	If platforms are floating then treat as Boat Pontoons below. Fishing platforms are constructed to gain access to deeper water. Hence take extra care not to fall in. They are inherently slippery, so care is needed at all times.
<b><u>Boat Pontoons</u></b>	Beware that pontoons constantly move, and hence unstable, invariably wet and slippery. This makes walking on them difficult and possibly unsafe. Maximum caution is needed.
<b><u>Getting on, off Moving around On boats</u></b>	Like pontoons, boats also constantly move and are unstable when their balance is disturbed. The motion of boat and getting on, off and moving around on boats disturbs the balance, hence Maximum caution is needed when getting on, off and moving around on boats.
<b><u>Other boats</u></b>	Beware other boats can approach you from all angles and may be unpredictable in their direction, when 'on the motor' you should always give way to those drifting or under sail.
<b><u>Falling in the water</u></b>	Falling in the water may cause drowning, <b>it's recommended a buoyancy aid is worn at all times</b> when on, in or near water.
<b><u>Electric fences</u></b>	Electric fences that are used for the control of animals, periodically discharge high voltages. Contact with the wires may result in a painful electric shock, or worse.
<b><u>Weather Conditions</u></b>	When boat fishing, the weather may change suddenly and cause unforeseen dangerous water conditions. Be constantly aware of changing weather and its consequences.
<b><u>Foreign Countries</u></b>	When abroad different emergency protocols and arrangements may apply. They along with the language may be unfamiliar to you. You should before fishing seek an understanding of the safety arrangements with the host countries officials

#### Boat Qualifiers: Northern Federation Qualifiers

**Location & Date:** Stocks Reservoir Fishery. Slaidburn. Sunday 16<sup>h</sup> May, and Kielder Reservoir, Northumberland. Sunday 13<sup>th</sup> June

**Type of fishing:** Fly Fishing from drifting Boat

**Specific Risks:** see Paths, Lightning, Casting, Hooks / Flies, Weils Disease, Boat Pontoons, Getting on, off & moving around on boats, Other boats, Weather Conditions, and Falling in the water above

**Location & Date:** River Swale, Grinton, North Yorkshire

Sunday 23<sup>rd</sup> May

**Type of fishing:** River Fly Fishing

**Specific Risks:** see Paths, Banks, Power lines, Wading, Lightning, Casting, Hooks / Flies, Weighted Flies, Trees, Animals, Weils Disease, and Falling in the water above

## CEFF General Competition Rule etc.

### Tradition

Fishing in any CEFF competition will be carried out in the spirit of, and with respect for, the traditions of the sport.

### Betting

Competitors are not permitted to engage in any form of betting, including sweepstakes, connected with their competitions.

### Eligibility

Where required in England, all competitors must be in possession of a valid Environmental Agency rod licence. To Participate in a CEFF national competition, an individual must have been born in England, or be a citizen thereof, or have resided therein for at least 3 years preceding the date of the competition. For this purpose, Monmouthshire is considered to be part of Wales. Anyone living within 5 miles of the border between England and Scotland is considered eligible to fish for either country. Entry is limited to those who will be at least 18 years old on May 1<sup>st</sup> of the following year. Only one entry per person per year is allowed in each CEFF national competition.

### Disputes and Complaints

Any dispute or complaint must be reported to a match official within 30 minutes of the end of the match. A sub-committee is to be formed of the organiser and a minimum of two officials of the organisation responsible. They shall adjudicate within one hour. If the sub-committee considers that a competitor has not complied with the rules, it may disqualify. It may also refer the matter for further disciplinary action. In that case, a full report must be made to the appropriate authority within 7 days. A competitor may appeal against a decision to the CEFF, (or *Organising Body as appropriate*) in writing, within 7 days of being informed of any penalty. Any review must be concluded within 28 days.

## LOCH STYLE RULES (BOAT). Local rule variations may apply; these will be advised at entry confirmation and at the competition briefing

### Flies & Hooks

Matches shall be fished with artificial fly only. Flies may be dressed on single or double hooks; tandem flies are not permitted. In the case of a double hook, the angle between the bends shall not exceed 90 degrees and, when viewed from the side, the bends must lie one behind the other. No fly shall be artificially weighted. No more than 4 flies, only one of which may be dressed on a double hook, may be mounted on a cast and flies must be at least 20 inches apart. Hooks may not measure more than five-eighths of an inch overall, including the eye. The overall length of the fly may not exceed fifteen-sixteenths of an inch. Suspected illegal flies should be put into an envelope and signed over the seal by the angler/boat partner/boatman. The envelope should be presented to a Match Official at the end of the competition. Attractor chemicals and light emitters may not be used on flies.

### Lines & Leaders

Lines, casts and leaders shall not be additionally weighted. No form of shooting line, metal core line or metal core braided leaders is permitted.

### Rods

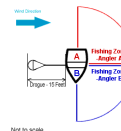
A competitor may use one rod not exceeding 12 feet in length and may have a spare rod of the same maximum length. But only one rod may be mounted. A rod is considered mounted if any two sections are joined or if a reel or line is attached. A competitor's rod, when working flies or retrieving casts must be hand held and must be above water level.

### Drifting

Boats must be allowed to drift freely during fishing and must not be held on oars, drogues or engine in such a manner as to interfere with, or gain advantage over, any other competitor. Flies must be out of the water whilst the engine is running or the boat is in forward or reverse motion. Trolling lines or flies behind the boat is never permitted. During a match no boat may encroach within 50 yards radius of any other boat engaged in fishing. The water between boats may be shared. The match organiser may extend the 50 yard separation as befits the venue.

### Fishing Zone

Competitors shall fish within the bounds shown in this diagram and may not fish in their partners' zones.



### Out of Bounds Areas

Whilst a competitor may cast into an 'Out of Bounds' area, the boat may not enter these areas whether fishing or not.

### Sitting & Standing

Boat seats, thwart boards and the use of tackle boxes as seats are allowed, provided the height of the seat is not more than 5 inches above the gunwales. - Note - 'Backrests' are also allowed on boat seats - Competitors must not stand in the boat when casting or retrieving line. Standing in the boat whilst fishing is allowed only when playing or landing a fish.

### Command of the Boat

Command of the boat will change every two hours. Competitors shall change ends every two hours or as mutually agreed.

### Drogues

A single un-weighted drogue is permitted, of no more than 60 x 60 inches or 25 square feet. It may be fitted with functional metal fittings such as small link rings and swivels. The only control device allowed is a 'G' clamp. The drogue may be fixed on either side of the boat such that the drift is square to the wind. The drogue must trail no more than 15 feet behind the boat.

### Respect for Other Anglers

In congested areas, boats must not deny reasonable access to other boats by undertaking repeated short drifts. Special care must be taken in such circumstances, especially when manoeuvring the boat. -Boats are to keep at least 50 yards from bank anglers.

### Electronic Devices

Competitors may not use electronic devices, such as echo-sounders, fish finders or radios during official practice days or match days. MOBILE TELEPHONES are ONLY allowed on PRACTICE DAYS.

## CEFF Loch-Style Match Rules

### Local Rules

The match organiser, hereinafter referred to as the 'organiser', will advise competitors of any local rules which augment or otherwise affect the competition rules.

### Hours of Fishing

The organiser shall fix the hours of fishing. In the event of dangerous weather, the organiser may change them, or the date, as necessary. Competitors shall not fish before the start time and must begin from the start zone. They must return to the finishing zone, in the boat in which they set out, no later than the match finish time.

### Species & Size of Fish

Trout are the only permitted species. The organiser will specify any limitations, e.g. restrictions on brown trout, or the minimum size that may be weighed in. To prevent competition results being distorted by an individual fish, the organiser may fix a maximum weight, usually 4 lbs. In this event, the trout would weigh 4 lbs for the bag-weight but be credited with its full weight for any heaviest fish award.

### Weighing-In

If both boat partners reach their individual bag limits early, they may leave the water and hand in their bags to an official. The fish should be collected from the official and presented at the weigh-in. All competitors must report directly to the weigh-in immediately after the match finish time. Nil returns are required. Anyone not reporting within 30 minutes of the end of the match will be deemed to have a nil return.

### Placings

Competition results will be decided by the bag-weight of the fish, the higher weight taking precedence. If weights are equal, the greater number of trout will prevail. If there is still a tie, the heaviest individual fish will take precedence. The organiser and the water authority will agree a bag limit per individual. When a competitor reaches that limit, the time is to be recorded by agreement with the boatman and/or boat partner. A time-bonus weight, set by the organiser, will be added to the angler's catch for every full quarter of an hour remaining in the competition.

### Boatmen & Boat Pairings

Boatmen and boat pairings will be allocated by public ballot at a time and place announced by the organiser - or by a computerised draw system which may be used if agreed by the AGM of the CEFF, Federation or club concerned.

### Emergencies

If assistance is required, an oar should be raised to alert officials. During competition hours, a boat may be beached only in an emergency such as medical, boat, or severe weather problems. In these circumstances, the competitors may if necessary return by other means but must report immediately to an official who will treat the incident as though it were a complaint made under CEFF Competition Rule 4 - See CEFF General Competition Rules.

### Safety

Competitors are strongly advised to wear buoyancy aids and eye protectors when either travelling in, or fishing from boats.

## **RIVER RULES. Local rule variations may apply; these will be advised at entry confirmation and at the competition briefing**

Matches shall be fished with artificial flies on barbless or de-barbed single hooks. Not more than three flies shall be mounted on a cast. Flies may be artificially weighted.

Fly irons will measure not more than five-eighths of an inch overall, including the eye. The overall length of the fly shall not exceed fifteen-sixteenths of an inch. Flies may be of any pattern and material and may be fished floating or sunk. Attractor chemicals and the use of light emitters are debarred.

A competitor may use only one rod at a time (maximum length 12 feet) but may have a second ready mounted as a spare. Any manufactured line may be used. Braided leaders, weighted or un-weighted, are allowed. Coloured sleeving may be used at the end of the fly line to improve visibility but no other bite indicators are permitted. A 'sacrificial' floating fly is not deemed to be a bite indicator provided it is one of the three permitted flies.

Competitors must provide for themselves landing nets made of knotless mesh.

Competitors may fish anywhere within their beats provided that they do not approach within 30 metres of another competitor who is fishing. They may fish the same spot for up to 30 minutes. After that, if requested by another competitor, they must move at least 30 metres and may not return to the spot for at least 30 minutes. At the end of each session every competitor must move at least 30 metres from the spot he/she is fishing, irrespective of how long he/she has fished there.

No competitor may walk or cast outside the beat. Should a fish move outside the beat, it must be played from and landed within the beat. If a fish is hooked at the end of a session, five minutes of the next session is allowed in which to net it.

### **Local Rules**

The match organiser, hereinafter referred to as the 'organiser' will advise competitors of any local rules which augment or otherwise affect the following rules.

### **Hours of fishing**

The organiser will fix the hours of fishing.

### **Species & Size of Fish**

Trout and grayling are the only permitted species. The minimum size limit that may be set in England is 15cm from nose to the tips of the tail. The organiser will specify and further limitations for a particular event.

### **Beat Arrangements**

The organiser will divide the competition venue into four beats, with 8 competitions per beat. The draw for the beats will be carried out by a minimum of two CEFF officials.

### **Controllers**

Each competitor will have a controller who will stay with the same competitor throughout the competition. Controllers will be responsible for ensuring that those on their beats comply with the rules. To be fair to all, they are not to give advice, net fish or in any other way give advantage to their competitors.

### **Catching & Recording**

Catch and release will apply. All fish must be netted and presented to the controllers whilst still in the landing net. At the time of netting, the hook must be in the fish's mouth; if the fly drops out in the net, the fish will still count. The controller and competitor will agree the overall length of the fish and the controller will record it on the score card. The competitor will carefully return the fish to the river, making sure that it can swim away before releasing it.

### **Placings**

Each qualifying fish will score 20 points plus 1 point for each centimetre or part thereof. For example, a fish of 30.3 centimetres will score 20 plus 31, i.e. 51 fish points. The scores for the four sessions will be recorded separately. At the end of each session, both the controller and the competitor will initial the scorecard. Competitors from each of the four beats will be 'placed' separately, according to the points they have scored in each of the four sessions, i.e. in each session, the top competitor on each beat will earn a '1 placing', the second a '2 placing' and so on. A blank will earn an '8 placing'. Individuals' placings in the four sessions will be summed and their totals will decide their positions in the competition. The top individual will have the lowest total of 'placings' and so on. A tie will be decided on highest fish points.

**Assistance to the Competition Organisers** If anyone sees anything which appears to contravene the competition rules, he/she is asking to notify the individual concerned if possible, and to report to the organiser under the procedure set out in the CEFF General Fishing Rules.

## **BANK OPEN INDIVIDUAL & TEAM (CEFF AIRFLO CLASSIC).**

The Airflo Classic 2008 Competitions will be organized by the Confederation of English Fly Fishers and will be fished to the CEFF English Open Small Water Stillwater Championship Rules with the exception of the CEFF Competition rules on eligibility. The competition will consist of a number of Regional Heats throughout the UK cumulating in separate Grand Finals for individual & team entrants at Elinor Fishery, Northants on Saturday 1<sup>st</sup> October 2008 for individuals and Sunday 2<sup>nd</sup> October for teams. Entrants may enter as many Regional Heats as they like, although we cannot guarantee a place as there is a limit to the number of places and reserve the right to move the individual /Team to an alternative venue. Entries will be dealt with on a first come first served basis.

The initial entry to the Individual Competition and to the Team Competition will be advised on the entry form. Both include the special entry pack(s). You may enter other heats but you will not receive an extra entry pack(s). Entry fees are used to cover Management costs and prizes. They are not refundable in any circumstances. Competitors will also be charged fishing fees for the heats and Grand finals. These will be payable on the day unless previously specified.

The number of qualifiers to the Grand Finals from each Regional heat will be calculated on a pro-rata to the overall entry numbers. At least 3 individuals from the individual competition and 1 team from the team competition will qualify from each heat.

If an individual or team qualifies more than once, due to multiple entries at the Regional heats, then their Grand Final place will be allocated to the reserve individuals or team at the relevant heats on completion of the heat.

Closing date for entries is 10 days prior to the date of the heat entered.

## **BANK OPEN INDIVIDUAL & TEAM (CEFF AIRFLO CLASSIC) RULES.**

Fishing in any CEFF competition will be carried out in the spirit of, and with respect for, the traditions of the sport. Where required in England, all competitors must be in possession of a valid Environmental Agency rod licence.

Accidentally foul hooked fish will be allowed throughout the Competition. Sight bobs must be capable of catching fish, I.E. they must include a barbless/de-barbed hook. Wading will be at the discretion of the heat organizer; However, All forms of waders that cover the hips (waist or chest waders) will be expressly banned at the Individual and Team Grand finals as will waterproof trousers covering Wellies or Waders.

Mobile telephones may be taken onto the fisheries, must be turned off and may only be used for emergency purposes. Mobile telephones or any other electronic communication device may not be used to communicate with other competitors under any circumstances, either by voice message or text message. Anglers found to be breaking this rule will be disqualified from the Competition. Fish finding devices are also banned from use during the day of the competition

A maximum of three rods, none exceeding 12' feet in length, may be carried in Heats and the Grand Finals, though only one at a time may be used. Competitors are responsible for providing their own knotless mesh landing nets. Irrespective of fishery rules, competitors are not permitted to use shooting heads or joined or lead-core lines. Any dispute or complaint must be reported to a match official within 30 minutes of the end of the match. For a Regional Heat the Match Organiser will adjudicate within one hour. For the Grand Final the National Organisers will adjudicate within one hour. If the adjudicator(s) considers that a competitor has not complied with the rules, it may disqualify. A competitor may appeal against a decision to the CEFF, (or Organising Body as appropriate) in writing, within 7 days of being informed of any penalty. Any review must be concluded within 28 days.

Competitors are not permitted to engage in any form of betting, including sweepstakes, connected with their competitions.

## **CEFF Child & Young Persons Protection Policy**

The CEFF maintains a policy for the protection of Children & Young Persons at CEFF organised events. The Northern Federation as part of the CEFF have adopted and comply with the requirements of this policy.
